RE: AMENDMENT TO THE TRANSPORTATION IMPROVEMENT PROGRAM (TIP) OF JULY 1, 2008 (FY-2009) TO JUNE 30, 2012 (FY-2012)

WHEREAS the Federal Highway Act of 1962, as amended, and the Urban Mass Transportation Act of 1964, as amended, provides for an urban transportation planning process; and

WHEREAS the Safe, Accountable, Flexible and Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) authorizes funding to improve our nation's transportation system for highways, highway safety, and transit for the 5-year period of 2005-2009; and

WHEREAS the Rockford Metropolitan Agency for Planning (RMAP) is the Metropolitan Planning Organization (MPO) for the Rockford Urban and Metropolitan Areas, and the Policy Committee has the specific responsibility to direct and administer the continuing urban transportation planning process; and

WHEREAS the Policy Committee has adopted the FY-2009 Transportation Improvement Program (TIP) for July 1, 2008 to June 30, 2012 on January 29, 2009; and

WHEREAS the Federal Highway Administration and the Federal Transit Administration have approved the FY 2009 to FY 2012 RMAP TIP; and

WHEREAS the Illinois Department of Transportation -- Region 2--District 2 (IDOT) and the City of Rockford have indicated that the FY 2009 to FY 2012 RMAP TIP should be amended; and

WHEREAS IDOT and the City of Rockford have identified verified funding sources that are available to commit for these projects which is listed in "Addendum A" to this RMAP Resolution; and

WHEREAS these additional projects being amending into the January 29, 2009, adopted version of the FY 2009 RMAP TIP will not effect or impact the existing projects already listed in the FY 2009 RMAP TIP;
