RATS RTMD BOONE COUNTY CITY OF BELVIDERE AGREEMENT FOR SERVICE EXPANSION AREA IN BOONE COUNTY: During March of 2004 an Agreement was signed by these four agencies pertaining to RMTD expansion of their urban transit service and area into Boone County and the City of Belvidere.
