- 3. RATS FY-2007 UNIFIED WORK PROGRAM (UWP) – RATS RESOLUTION 2006-6:** RATS staff distributed the draft FY 2007 UWP at the March 23rd and April 20th Technical Committee meetings. The Technical Committee will make a recommendation on the RATS UWP at this meeting for the May 25th RATS Policy Committee meeting.
- 4. IL 173 CORRIDOR PLAN – RATS RESOLUTION 2006-7:** In October 1994, RATS adopted a corridor access plan for IL 173 between IL 251 and Belvidere Road. Since that time, the planned development that was anticipated to occur in this corridor is currently underway. As a result of the economic and residential development in the past six-years, the construction of the planned interchange at Interstate 39/90 (Northwest Tollway), and future growth capability in this section of Winnebago County / Loves Park / Machesney Park, an updated access plan has been prepared to facilitate travel patterns that are expected to occur within the planning horizon. The Technical Committee will make a recommendation on the RATS UWP at this meeting for the May 25th RATS Policy Committee meeting.
