RATS TECHNICAL COMMITTEE MEETING MINUTES April 20, 2006

Meeting was called to order by Mr. Steve Ernst of City of Rockford Public Works Department at 10:05 A.M. with a quorum present.

Mr. Steve Ernst welcomed the newest non-voting member of the technical committee, Rock River Water Reclamation District.

1. Approval of Minutes of March 23, 2006 RATS Technical Committee Meetings:

Mr. Steve Ernst entertained a motion to approve the Minutes of the March 23, 2006 Technical Committee with two spelling corrections to item #8, Communications. The spelling of Greg Stukel and Rocco Zucchero should be corrected. Motion was made and seconded and approved unanimously. The corrected minutes will appear on the RATS website.

2. Agency Reports:

The TIP Status report is available on the RATS website under the meeting calendar. Projects of note are listed below. Mr. Steve Ernst reminded the committee any updates might also be sent via e-mail to RATS.

2.1 Illinois Department of Transportation, District 2 – No report.

2.2 Winnebago County Highway Department – Construction has begun on Hononegah Road from 251 west and on Harrison to Baxter and Baxter to Perryville to I-39. Construction should last through June 2006.

2.3 City of Rockford Public Works – The amended CIP is working its way through Rockford City Council. Major projects, such as Auburn, Harrison, Kishwaukee and West State Street Crossover are still on track.

2.4 City of Loves Park – No report.

2.5 Machesney Park – Budget is moving through Machesney Park Council.

2.7 Rockford Mass Transit District – State has approved the paratransit facility project and funding is in place. The consultants are getting started.

2.9 Village of Cherry Valley – No report.

2.10 City of Rockford, Community Development Department – No report.

2.12 Belvidere/Boone County Regional Planning – The zoning ordinance has been approved along with the zoning map. Seeking matching funds for the IL-173 project. The projected scope of this project is from the Winnebago County line to the McHenry County line, incorporating the Village of Caledonia, Poplar Grove and Village of Capron. The main emphasis on land use planning, with transportation included.

2.13 Boone County Highway Department – Woodstock design is complete, letting in May. Genoa construction is 99%, with punch list items remaining.

2.14 City of Belvidere Public Works – Phase II engineering for Town Hall Road location study from Newburg Road to IL-76/Caledonia Rd. is underway and should be complete by the end of May. West 6th Street/ 7th Avenue is in phase II of construction and should be completed by the end of May. Phase II engineering for South Appleton/Chrysler Drive project is 80% complete. 2006 MFT overlay program has been approved by City of Belvidere Council and should be out to bid soon.

2.15 Village of Roscoe – Construction will begin within the next 30 days on the pedestrian path along Main Street from Bridge Street south to McDonald Road on the east side of right-of-way. Final engineering for McDonald Road from Main Street east to Rambouillet Road (and possibly further, depending on costs) will be ready for bid shortly.

2.16 Village of Winnebago - Ellida Street from South Street to US 20 is complete except for landscaping and punch list items.

2.24 Federal Highway Administration, Illinois Division – Many guidance's regarding SAFETEA-LU have been coming out with certain provisional deadlines July 1st. FHWA continues to work with IDOT and various committees to ease the process.

2.26 Rock River Water Reclamation District – No report.

3. RATS FY-2007 Unified Work Program (UWP):

Mr. Gary McIntyre indicated this document is still out for public review on the RATS website. A resolution for the adoption of the UWP, along with the annual certification that RATS is meeting all the requirements will be on the next agenda. City of Rockford council must also pass a resolution assuring that local funds are met.

Mr. Ernst reiterated that IDOT reported a couple of items that could effect the UWP. The hope is the UWP will be able to move forward as planned, but some changes may need to be made. The UWP will be voted on next month in both Technical and Policy Committee meetings.

4. RATS FY-2007 to FY-2009 Transportation Improvement Program (TIP):

Mr. Gary McIntyre reminded the Committee that projects were still needed. RATS has received phase 1 projects for the City of Rockford, with the remaining projects due on Monday, April 24th. IDOT and Boone County have submitted their projects, and Ms. Hayes Morrison will be meeting with RMTD for that agency's projects.

The timetable was discussed next, with a draft scheduled for the June Technical Committee and adoption by the Policy Committee in July. Mr. Ernst indicated a draft of agency projects is acceptable for the June draft.

5. Progress Reports On:

5.1 Winnebago County Smart Growth

Continuing to work with the Village of Winnebago and Rockton.

5.2 Springfield Corridor Planning Study

The final draft should arrive soon.

5.3 NICTI Alternative Analysis

A press conference was held on April 18th where the NICTI logo was revealed. IDOT Division of Public and Environmental Transportation has agreed to fund the match of \$600,000 for the alternatives analysis. The RFQ deadline is April 28, 2006, with a selection to be made in July.

5.4 RMTD East Side Transfer Center

RMTD needs to meet with the City of Rockford to discuss zoning issues.

5.5 IL-173 Corridor Planning Study

A few minor modifications will be made before providing a copy of the study to the Technical Committee, including a scaled map.

5.6 RATS Bicycle/Pedestrian Study

Of the four teams to submit qualifications, TY Lin was selected. Mr. McIntyre stated TY Lin's familiarity with the RATS area, along with the expertise of John LaPlante, the senior member of the TY Lin team, were major factors in their selection. TY Lin was the consultant that assisted RATS with the LRTP. The contract still needs to be signed, however Mr. McIntyre believed the project should be complete late spring of 2007. Mr. McIntyre also mentioned there were certain funds that needed to be spent before July 2007. Mr. Steve Ernst pointed out all agencies will be requested to provide data to TY Lin which would be similar to the data collection already in progress as a result of a request by the Illinois State Toll Highway Authority.

6. Communications

Hanson Professional Services created a summary of the new SAFETEA-LU regulations. Mr. Steve Ernst commended their work and offered to lend his copy to anyone interested. The summary would be provided on the RATS website early next week. Mr. Shawn Goetz mentioned he may be able to provide additional copies.

Gary McIntyre attended the I-39 Corridor Study public meeting hosted by the Wisconsin Department of Transportation. Eleven interchanges between Madison and the State line will be under some type of construction designed to expand the corridor. The preferred alternative is to widen to the inside for the majority of the projects. Construction was scheduled for 2013. WisDOT is requesting a recommendation from the City of Rockford Council supporting the plan. Documentation from this public meeting will be posted on the RATS website.

7. Other Business

Mr. McIntyre explained the IL-173 corridor plan needs to be updated. A resolution for approval of the draft update will be brought to the Technical Committee in May. Mr. McIntyre will look into the possibility of posting more information on the RATS website.

Mr. Joe Vanderwerff invited the RATS Technical Committee to meet at Winnebago County Highway Transportation's new facilities located at 424 Springfield Avenue. Mr. Ernst believed a May or June meeting would be possible.

Mr. Steve Ernst mentioned the WinGIS technical meeting this afternoon has been moved to the WinGIS offices due to construction in the administration building.

Ms. Sherri Vanderwege invited the RATS Technical Committee to the open house for Baxter & Woodman's new offices on Thursday, April 27th, from 3-6 P.M. The office is still located in 555 North Court Street but has moved upstairs.

Mr. Steve Ernst explained that many member agencies of RATS are participating on efforts of safety and security efforts in Illinois, specifically terrorism. Mr. Ernst thought it would be beneficial to document all the efforts of the various agencies to include with the reports RATS provides to FHWA. Mr. Rich Lundin discussed some of the safety and security efforts by Transportation Committee. The document he presented will be posted on the RATS website.

At 10:58 A.M., with no further business to conduct, Mr. Steve Ernst entertained a motion to adjourn the meeting. The motion was made and seconded and approved unanimously.
