I am writing to express my strong support for the Illinois Department of Transportation's TIGER II grant application for construction of the downtown rail station and other site amenities in the City of Rockford.



The citizens of the Rockford region have shown overwhelming support for passenger rail projects and the elected officials that represent them are committed to work together to make this important regional initiative a reality.

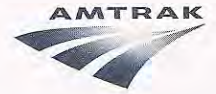

The National Railroad Passenger Corporation (Amtrak) would like to take this opportunity to express its support for the Illinois Department of Transportation's ("IDOT") application under the U.S. Department of Transportation's (DOT) National Infrastructure Investments "TIGER II Discretionary Grants" program, funded under the Transportation, Housing and Urban Development, and Related Agencies Appropriations Act for 2010, for preliminary engineering, final design, and construction of a proposed new multi-modal station at Rockford, Illinois which will serve proposed future Amtrak service.

At this time, we have an exciting opportunity to advance projects that are integral to developing a multi-modal, performance-based surface transportation system.
